# What to do if my circumstances change?

You must return your equipment to ACTES if you:

- · no longer need the equipment provided to you
- · move to a high-level residential care facility
- · plan to move out of the ACT.

Please contact the ACTES office to arrange the return of equipment.

## Planning for Emergencies:

- Make sure you have a phone that you can use if the power goes out.
- If the equipment is chargeable, always keep it fully charged.
- Talk to your primary health therapist about your equipment and what you can do if the equipment fails or there is an emergency.
- If you have life threatening problems, ring 000 for an ambulance.

ACT Equipment Scheme (ACTES) health.act.gov.au

The ACT Equipment Scheme (ACTES) provides access to a range of equipment for eligible applicants. We help people to live safely at home and participate in their community.

## Who is eligible?

To be eligible you must meet <u>all</u> of the following requirements:

- · be a permanent resident of Australia
- have resided in the ACT for at least 6 months
- have had a permanent disability for more than 2 years
- hold a current Centrelink Pension or Low Income Health Care Card in your name. Please note, this does not include the Senior Health Care Card (SHC) or a Mobility Allowance (MO).

#### What information is needed?

Children under 16 years of age need to provide a birth certificate

People over 16 years of age must have a full Australian Government Centrelink Concession Card in their name.

### Who is not eligible?

You are not eligible if you can:

- receive the equipment through a Department of Health Home Care Package
- receive the equipment from other government funded schemes including the National Disability Insurance Scheme
- claim the cost of the aid or equipment back through a private health fund insurance policy.

### What does ACTES provide?

ACTES will fully fund the following types of equipment:

- · Bariatric equipment
- Bathroom aids
- · Compression garments
- · Continence aids
- Hoist/Slings
- · Hospital beds
- Manual wheelchairs
- · Medical grade/custom footwear
- Mobility aids
- Foot orthoses
- Powered wheelchairs
- · Pressure care cushions
- · Pressure care mattresses
- Standers
- · Utility/Hilite chairs
- Wigs



## How do I apply?

Please make an application to ACTES using the ACTES application form. The form must be completed by all the following people:

- · The applicant's primary health therapist
- The applicant
- · The applicant's GP or Specialist

Application forms are available from the ACTES office and your primary health therapist.

# Who is my primary health therapist?

Your primary health therapist may be your:

- · continence advisor
- nurse practitioner/registered nurse
- occupational therapist
- physiotherapist
- podiatrist
- · prosthetist/orthotist.
